Discussion Items:

- 1) Lynfield Ministry Update (Dick)
 - Worship Service
 - Going well with a sustained amount of interest. Around 50/50 mix between Lynfield and EBFC attenders.
 - Continuing to struggle to find enough persons to preach; will move to seek a part-time person to oversee the ministry.
 - o Part-Time Lynfield Ministry Person Job Description
 - Spanish-speaker preferred but not totally required; aware of cultural differences or from the culture.
 - Formal Bible training (or in school)
 - In agreement with our Faith and Order
 - Committed to being in the community
 - Counseling ability
 - Administrative ability
 - Teaching/preaching

- Elder? Some hours of meeting with staff and elders, but Shepherd's List would be the Lynfield Community
- Part-time (15 hours a week?), \$20/hour? \$15,000/year
- Elders approved posting the job description, but will seek those from inside EBFC first before we post outside.
- We will also seek to use several people from EBFC to add to the preaching circuit

2) Ebenezer Mobile App (Dick)

- Pastor Dick demonstrated the new church app which we plan to roll out the IOS version by March 31
- 3) <u>Questionable Authors in EBFC Library</u> Elder's discussed and voted to remove the following authors from our library:

4) Faith Promise Cards

- o Contributors will earmark "Faith Promise" on their offering envelopes
- o Faith Promise giving will be used for local & global outreach

5) Fover Modification Update (Mike)

- o Foyer flooring is being scheduled to be installed before Easter
- Members of the Property Committee met with Bergey Electric to discuss lighting options in the foyer
- o Discussions about updating paint colors in the foyer have also begun

6) <u>Outdoor Sign Replacement Update</u> (Mike)

- Our current sign sizes are grandfathered in with regard to township requirements
- Any addition of an LED display would require a variance which would need township approval
- The property committee is reviewing sign designs that have been provided by Horizon Signs
